

ORDINANCE NO. 126

**AN ORDINANCE DESIGNATING  
CERTAIN STREET AS NO PARKING ZONES  
DURING SNOW EMERGENCIES**

AND NOW, be it ordained and enacted, and it is hereby ordained and enacted by the Board of Supervisors of West Cocalico Township, as follows:

1. The parking of vehicles of any sort upon the cartway of the designated streets hereafter provided during snow emergencies (for purposes of this ordinance a "snow emergency" is defined as the period of time between the accumulation of any measurable snow or sleet upon a designated street until its substantial removal from same, or between the accumulation of a sufficient amount of ice as to render a designated street hazardous) is hereby prohibited.

2. In addition to any streets previously designated by Township ordinance, parking during snow emergencies is prohibited on the cartway of the following streets, along their entire length within West Cocalico Township:

- a. Village Spring Lane
- b. Farrow Lane
- c. Pheasant Lane
- d. Krueger Drive
- e. Hollow Road
- f. Pelham Road
- g. Cedar Court
- h. Circle Drive
- i. Bridle Path Way
- j. Hill Drive
- k. Walnut Lane
- l. Green Court
- m. Pine Crest Drive
- n. Martin Circle
- o. Boulder Drive
- p. Pebble Lane
- q. Sandra Circle
- r. Clearview Drive
- s. Joshua Circle
- t. Sunrise Lane
- u. Linda Lane

3. The aforesaid prohibition shall extend to the full length and cartway breadth of the above-named streets (regardless of designation as lane, drive, etc.) during a snow emergency as defined above.

4. Any person, owner, or operator who violates this ordinance is guilty of a summary offense and shall, upon conviction, be sentenced to pay a fine of Fifteen Dollars (\$15.00).

5. The Township shall, as soon as practical after the effective date of this ordinance, erect such signs as shall be reasonably necessary to provide notice of the parking prohibition as provided in this Ordinance. Such signs shall bear the designation: "No Parking Until Snow Is Removed," and shall otherwise conform in size, shape, design, location, color, and number as may be required by the regulations of the Pennsylvania Department of Transportation.


6. Any parts of any Ordinances specifically inconsistent with the provisions of the Ordinance, are repealed.


7. This Ordinance shall take effect five (5) days after enactment.
