<u>WEST COCALICO TOWNSHIP</u> NO-IMPACT, HOME-BASED BUSINESS REQUIREMENTS

A no-impact, home-based business is a business or commercial activity administered or conducted as an accessory use which is clearly secondary to the use as a residential dwelling and which involves no customer, client or patient traffic, whether vehicular or pedestrian, pickup, delivery or removal functions to or from the premises, in excess of those normally associated with residential use. In addition to the above, the business or commercial activity must satisfy all of the following requirements:

- 1. The business activity shall be compatible with the residential use of the property and surrounding uses.
- 2. The business shall employ no employees other than family members residing in the dwelling.
- 3. There shall be no display or sale of retail goods and no stockpiling or inventory of a substantial nature.
- 4. There shall be no outside appearance of a business use, including, but not limited to parking, signs, or lights. (NOTE; SECTION 1704.3. OF THE WEST COCALICO TOWNSHIP ZONING ORDINANCE PERMITS THE PARKING OF ONE (1) COMMERCIAL VEHICLE UP TO ONE (1) TON ON A RESIDENTIAL LOT BY AN INDIVIDUAL FOR HIS LIVELIHOOD FOR A BUSINESS NOT CONDUCTED ON THE PREMISES.)
- 5. The business activity may no use any equipment or process which creates noise, vibration, glare, fumes, odors or electrical or electronic interference, including interference with radio or television reception, which is detectable in the neighborhood.
- 6. The business activity may not generate any solid waste or sewage discharge, in volume or type, which is not normally associated with residential use in the neighborhood.
- 7. The business activity shall be conducted only within the dwelling and may not occupy more than twenty-five percent (25%) of the habitable floor area.
- 8. The business may not involve any illegal activity.
