

WEST COCALICO TOWNSHIP

The Secretary, Jeff Sauder called the meeting to order at 7:04 p.m.

Supervisors: James Stoner, Leon Eby and Jeff Sauder.

Others present: Carolyn Hildebrand, Manager; Joielyn Current, Administrative Assistant; Tom Showalter, Roadmaster; Lieutenant Tom Shumaker, Ephrata Police Department and Justin Stoltzfus, LNP.

Public Comment – none

J.J. Stoner motioned to approve the minutes from the meeting on April 21, 2020. Leon Eby seconded the motion. The motion passed unanimously.

Leon Eby motioned to approve the attached list of checks totaling \$23999.12. J.J. Stoner seconded the motion. The motion passed unanimously.

Lieutenant Tom Shumaker, Ephrata Police Department presented the police report as follows:

1. There were a total of 129 incidents in the township for the month of April.

Tom Showalter presented the Roadmaster's report as follows:

1. Stormwater pipe was extended on Short Road.
2. Stormwater work was done on Whitehall Road.
3. Scrap metal was taken to be recycled.
4. Road crew started mowing.
5. Repair work was done to mowers.
6. Checked roads after heavy rain.
7. AMS Sealer was here this week. The following roads were completed: Indiantown Road (between Short & Line Rd), Gockley Road, Pine View Drive, Project Drive and Whitehall Road were all sealed.
8. Met with H&K regarding road widening.
9. Replaced stop sign.

J.J. Stoner motioned to approve the lowest bid or insurance company recommendation for the repair to the fender on a township vehicle. Leon Eby seconded the motion. The motion passed unanimously.

Indiantown and Line Road intersection improvements – Ephrata Police Department will patrol the area to see if situation improves.

Bridge Inspection List – discussion was held on bridges in the township. Tabled for now to see where things are financially.

J.J. Stoner motioned to award road widening bid to New Enterprise for \$51,407.16. Leon Eby seconded the motion. The motion passed unanimously.

Request to have PennDot do a study to see if driveway ahead signs are warranted for 1380 Texter Mountain Road – Ephrata Police Department will gather more information with speed signs to see if there is a problem on the road.

Resident request for speed signs on Sportsman Road – Carolyn will check with Josele to see if signs can be posted. Ephrata Police Department will also check to see what speed should be posted.

Resolution No. 05072020 discussion – tabled until next meeting.

Leon Eby motioned to appoint Carolyn Hildebrand as Vector officer for West Cocalico Township. J.J. Stoner seconded the motion. The motion passed unanimously.

The meeting was adjourned at 9:19 pm from executive session.
