Mike Palm motioned to approve the minutes from the meeting held on July 13, 2021. Larry Gensemer seconded the motion. Motion carried.

Mike Palm motioned to approve the attached list of checks from the Sewer Fund in the amount of \$189,577.69. Larry Gensemer seconded the motion. Motion carried.

Matt Boggs presented the following Engineer's Report for Sewer:

#### Sewer Treatment Plant

- Permit submission has been completed with the April 22<sup>nd</sup> submission for the Joint Permit.
- Comments have been received by the Conservation District dated April 21, 2021.
- Comments have been received by Rettew dated April 20, 2021. Entech will incorporate comments from Rettew with the Conservation District comments.
- Building Committee met August 5 to review comments from the latest set of plans, and to review final questions on the final design. The plans have also been provided to Rettew for technical review for the treatment process.
- The front-end section of the specifications have been provided to the Authority's solicitor for review and comments have been received and incorporated.
- An easement plan and description are being prepared for the proposed outfall for the treatment plant. The Agreement has been prepared by the Solicitor.
- There has been further communications with the RR regarding the license agreement and the agreement required for the track crossings. Entech will work with the manager and solicitor to resolve outstanding items with the agreements.

## Sanitary Sewer Collection System Extensions

 Survey has been received from Ott Consulting and preliminary design is currently being prepared. Progress drawings will be provided at the September Authority meeting.

### Giovanni's Pizza Sewer Connection

 The neighbors to Giovanni's Pizza, 174 E. Main St., are interested in connecting to the sanitary sewer. Easements remain outstanding and are to be obtained by the property owner.

### 320 Creamery Road

 A review letter was submitted on July 28, 2021. Technical comments have been addressed. The property owner will be obtaining two easements for the proposed lateral.

# Corrosion Control Treatment Feasibility Study

 During a previous triennial monitoring for lead and copper, the copper action level was exceeded. The Authority authorized Entech to prepare a Corrosion Control Treatment Feasibility Study during the July Authority meeting. Samples have been taken and are currently being evaluated. Sample results have been sent to Herb Spencer, the treatment specialist, to provide additional recommendations.
