Leon Eby motioned to request PennDot do a traffic study at the 3 way stop on Route 897 and at the Line Road and Wabash Road intersections. Jeff Sauder seconded the motion. Motion passed unanimously.

JJ Stoner motioned accept Richard Stauffer's resignation from the Cocalico UCC Appeal Board. Leon Eby seconded the motion. Motion passed unanimously.

JJ Stoner motioned to appoint Michael Steffy as the Township representative on the Cocalico UCC Appeal Board. Leon Eby seconded the motion. Motion passed unanimously.

On a motion by Leon Eby and seconded by Jeff Sauder, the meeting was adjourned at 8:35 p.m.
