Leon Eby motioned to approve Memorandum of Understanding between LCPC and the Township. Ray Burns seconded the motion. Motion passed unanimously.

Ray Burns motioned to approve Resolution 07192016, check countersignature plan. Leon Eby seconded the motion. Motion passed unanimously.
