Ray Burns motioned to approve minutes from the May 17, 2016 meeting. Leon Eby seconded the motion. The motion passed unanimously.

- 4. I met with Mike LaSala, Landstudies, and Ben Webber, Rettew, to discuss the draft of the SWMP plan on May 24th.
- 5. I attended the UCC appeal board meeting for Leon Eby on June 1st.
- 6. I went with Susan Martin, Lancaster SPCA, to meet with a resident regarding the health of his horses on May 24th.

JJ Stoner announced the recent passing of long-time employee Peggy Showalter.

JJ Stoner clarified the Act 537 letter to the public stating that only 15% of township residents without public sewer will be surveyed.

Lori Berger asked about the police work space. JJ stated that the Supervisors of West Cocalico met with EPD and the work space is on hold at this time. We will be trying to save money and do most of the work ourselves, but it is not in the budget this year. Looking at the budget for next year and waiting to see if Ephrata Borough could share costs. No grant money was issued for this year.
