Larry Gensemer seconded the motion. Motion carried.

Jay Bauder motioned to accept conditional approval of the quote from Liberty Environmental to complete all wetland, waterway, and bog turtle surveys for all sewer extensions in the amount of \$16,300, contingent on comments being addressed by the Solicitor. Larry Gensemer seconded the motion. Motion carried.

 - Bidding in early Summer.
 - o Plant construction complete by early 2023.
- Sewer Extension next steps:
- Solicitor provided comment on bog turtle survey proposal. Recommend proceeding with Liberty Environmental, contingent on comments being addressed.
 - Prepare and mail bog turtle survey notice.
- o Topographic surveys to be conducted after bog turtle surveys, and consent received from property owners.
 - Sewer extensions to be completed shortly after new plant is online.

Larry Gensemer motioned to appoint Fulton Bank as the paying agent for the bonds. Jay Bauder seconded the motion. Motion carried.

Jay Bauder motioned to approve the attached list of checks from the Water Fund totaling \$18,426.61. Mike Palm seconded the motion. Motion carried.
