Leon Eby motioned to approve the minutes from meeting on May 19, 2026. J.J. Stoner seconded the motion. The motion passed unanimously.

Leon Eby motioned to approve the attached list of checks totaling \$164,016.71. J.J. Stoner seconded the motion. The motion passed unanimously.

J.J. Stoner reviewed the Police Report.

Tom Showalter presented the Roadmaster's report as follows:

1. Completed the chip seal, used 200 tons of stone and 8,270 gallons of oil. The roads that were completed are as follows: Leisey Rd, S. Wollups Hill Rd, N. Windy Mansion Rd, S. Blainsport Rd, Hartings Park Rd, Hackman Rd, Pleasant View Rd, Strickler Rd, Camp Rodgers Rd, Sunny Side Rd, Pine Crest Dr, Hillside Rd, Lower Hillside Rd, Sandy Hill Rd, Forest Rd, Stobers Dam Rd, and Swamp Bridge Rd .
2. In the Whispering Pine Development the weeds were sprayed at the curb line by Texter Mountain Nursery, weeds were removed, streets swept, and trees trimmed.
3. Contacted Asphalt Industries to get chip seal started.
4. Installed 4 15" storm water pipes on Yellow Mountain Road.
5. Meet with Esco and Choice Security for Chapel Gate Security.
6. Mowed the Parks.

The Zoning Officer's report was presented.

Old Business:

Leon Eby motioned to award the bid for Swamp Bridge Rd culvert project to Construction Master Services LLC in the amount of \$399,978.00. J.J. Stoner seconded the motion. The motion passed unanimously.

The car show at Swamp Church Road on July 25th has been cancelled.

New Business:

There was discussion concerning PennDot installing a flasher at Schoeneck. This will be tabled to Old Business for the next meeting.
